

The Constitution of Students' Union UCL

UCL Ghana Society

1 Name

- 1.1 The name of the club/society shall be Students' Union UCL Ghana Society.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

President

3.4 Promo Officer

- Promote UCL Ghana Society and its events
- Manage UCL Ghana society's social media accounts
- Help committee members' organize events
- Designing flyers and posters, promotional videos and create Facebook events.

3.5 Events Director


- Support committee with event planning and creativity
- Help Lead and ensure events are going according to plan and all resources are available


- Work with promo officers and secretary to ensure all events are on the calendar, up to date and shared with members of the society.

- 3.6 Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.7 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.8 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:
- Meet and Greet
 - Games nights
 - Movie nights
 - Karaoke and Quiz night
 - Akan Twi language lessons
 - Independence Day celebrations
 - Book Club
 - End of year BBQ/picnic
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:
- Intersociety debates and events
 - Charity fundraising events
 - Lifestyle Talks (e.g. Mental Health, Addiction, Depression)
 - Volunteering
- 4.5 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Zone shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Ghana Society . By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
