

The constitution of the Students' Union UCL

UCL Ice Club

1 Name

- 1.1. The name of the club shall be the "University College London Ice Club".
- 1.2. The club shall be affiliated to Students' Union UCL

2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL Policy, and shall be bound by the Students' Union UCL Constitution, the Club and Society Regulations and Good Practice Guidelines.
- 2.2 The club/society stresses that it abides by the Students' Union UCL Equal Opportunities Policy, and that club/society regulations pertaining to membership of the club/society or election to management of the club/society shall not contravene this policy.

3 The Society Committee

- 3.1 The committee shall consist of the following members:

- 3.1.1 President
- 3.1.2 Treasurer
- 3.1.3 A - Team Hockey Manager
- 3.1.4 B – Team Hockey Manager
- 3.1.5 C Team Hockey Captain
- 3.1.6 Figure Skating Manager (2)
- 3.1.7 Vice President
- 3.1.8 Welfare Secretary
- 3.1.9 Publicity & Recruitment Secretary
- 3.1.10 General Secretary

- 3.2 All committee must be members of the club/society and therefore must pay the full membership fee at the start of the year. They must also be current students on a full or part time course at UCL.
- 3.3 The post of President and Treasurer shall not be held by the same person, as per Students' Union UCL regulations.
- 3.4 Office shall be held from August 1st to July 31st of each academic year.

3.5 An outgoing committee member may be eligible for re-election should they remain a member of the club.

4 Terms, Aims and Objectives

4.1 The club/society shall hold the following as its aims and objectives.

4.2 The club/society shall strive to fulfil these aims and objectives over the course of the academic year as a commitment to its membership.

To teach beginners to ice skate.
To foster the development of existing ice skaters.
To maintain the growth of the University College London ice hockey team & enter a competitive league and tournaments.
To send experienced figure skaters to regional competitions & events.

4.3 The core activities of the society shall be: **Ice Hockey Varsity, Figure skating, Ice Hockey**

4.4 In addition, the club/society shall also strive to organise other activities for its members where possible: **Ice Factor, Social Skates**

4.5 This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a society general meeting. Activities Network Executive shall approve any such alterations.


