

The Constitution of Students' Union UCL Catholic Society

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL Catholic Society.
- 1.2. The club/society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. The Society Committee

President

- 3.1. The President's role is laid out in section 5.7 of the Club and Society Regulations.

Treasurer

- 3.2. The Treasurer's role is laid out in section 5.8 of the Club and Society Regulations. The Treasurer shall also assume the duties of a Vice President. These duties include supporting the President in the overall organisation of the Committee and sharing greater responsibility in planning the core activities of the society.

Welfare Officer

- 3.3. The Welfare Officer's role is laid out in section 5.9 of the Club and Society Regulations. The Welfare Officer shall also assume the duties of the Volunteering Officer. These duties include organising the weekly volunteering project and publicising one-off volunteering initiatives.

Additional Committee Members

3.4. Worship and Interfaith Officer

The Worship and Interfaith Officer's role is to organise prayer sessions and liaise with other faith societies in organising interfaith events.

3.5. Social and Media Design Officer

The Social and Media Design Officer's role is to organise socials and design posters for the different media outlets of the society.

3.6. Trips and Communications Officer

The Trips and Communications Officer's role is to organise retreats and pilgrimages, as well as to promote society events and manage the society's social media accounts.

- 3.7. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.8. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.9. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.2. The objective of the society is to provide an environment where Catholics and non-Catholics alike can learn and explore issues relating to the Catholic faith openly and honestly in a friendly, comfortable and welcoming environment.
- 4.3. The core activities of the society shall be: prayer and reflection sessions, talks from external speakers, student-led sharing and discussion sessions, volunteering initiatives, interfaith events, annual Carol Service, inter-society and social events.
- 4.4. In addition, the club/society shall also strive to organise other activities for its members where possible: one-off dinner gatherings, reading week retreats, annual pilgrimages.
- 4.5. This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Catholic Society. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
