

## The Constitution of Students' Union UCL

### CYPRriot AND HELLENIC SOCIETY

#### 1 Name

- 1.1 The name of the Cypriot and Hellenic Society shall be Students' Union UCL.
- 1.2 The Cypriot and Hellenic Society shall be affiliated to Students' Union UCL.

#### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the Cypriot and Hellenic Society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The Cypriot and Hellenic Society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the Cypriot and Hellenic Society or election to the Cypriot and Hellenic Society shall not contravene this policy.

### 3.4 Additional Committee Role Title



A description of specific tasks carried out by the additional committee role should be briefly outlined.

- 3.5 Management of the Cypriot and Hellenic Society shall be vested in the Cypriot and Hellenic Society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate Cypriot and Hellenic Society activities.
- 3.6 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7 Committee members are elected to represent the interests and well-being of the Cypriot and Hellenic Society members and are accountable to their members. If the Cypriot and Hellenic Society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4 Terms, Aims and Objectives

- 4.1 The Cypriot and Hellenic Society shall hold the following as its aims and objectives.
- 4.2 The Cypriot and Hellenic Society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the Cypriot and Hellenic Society shall be:  
**These are the activities that you will definitely carry out every academic year. The Union will only fund core activities.**
- Traditional Greek nights, several events depending on the interests of the members of the society, music nights, sports events, gathering events, and online events.
- 4.4 In addition, the Cypriot and Hellenic Society shall also strive to organise other activities for its members where possible:  
**These are the activities that you would like to carry out every academic year if you can. The Union will support these activities but not fund them.**
- Ski trip and/or trips to other cities near London ( if possible )
  - Board Games nights ( online )
- 4.5 This constitution shall be binding on the Cypriot and Hellenic Society officers, and shall only be altered by consent of two-thirds majority of the full members present at a Cypriot and Hellenic Society general meeting. The Activities Executive shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL **Cypriot and Hellenic Society**. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
