

# The Constitution of Students' Union UCL

# CLUB/SOCIETY NAME

### 1 Name

- 1.1 The name of the club/society shall be Students' Union UCL UCL Burmese society.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

## 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum & Articles</u> of Association, Byelaws, <u>Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

- 4.3 The core activities of the club/society shall be: UCL term 1 welcome event Chinlon game night Cultural night
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:

Collaboration with UCL asian society and UCL mahjong society.

- 4.5 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL UCL Burmese society . By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
