

## The Constitution of Students' Union UCL

### CLUB/SOCIETY NAME

#### 1 Name

- 1.1 The name of the club/society shall Modern Political History society.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

#### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the 'how to guides'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

#### 3 The Society Committee

##### President

#### 1.1.1 Vice-President

The vice president will assist the president with managing the society, ensure coordination among other committee members, and plan committee meetings when necessary. The Vice president is responsible for coordinating the Research Director and the Communication of the society. ( As seen on the mind map)

#### 1.1.2 Communication officer

The Communication Director's primary role is to create posts and messages and promptly publicise society and its events.

#### 1.1.3 Head of Events

The Head of Events' primary role is to organise events, such as organising speakers, visits, or collaboration with other societies.

#### 1.1.4 First-Year Representative

The First-Year Representative will be responsible for encouraging and ensuring first-year participation and inclusivity in the society and being their first point of contact.

#### 1.1.5 Postgraduate Representative

The Postgraduate Representative will encourage and ensure postgraduate participation and inclusivity in society and be their first point of contact.

#### 1.1.6 Research Fellows

The research fellows' role is to research and edit the society's content, which will be presented to all societal members weekly. Everyone can enroll monthly to become a research fellow.

#### 1.1.7 Research Director

The research Director's role is to organise the research fellows and to fact-check the content. He oversees having things to present weekly to the members of the society.

- 3.5 The management of the club/society shall be vested in the club/society committee, which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. Suppose club/society members are not satisfied with the performance of their representative officers. In that case, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.
- 3.8. Missing positions which were not taken in the late second semester elections shall be elected at the first meeting in September.

## 4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:

These are the activities that you will definitely carry out every academic year. The Union will only fund core activities.

  - 4.3.1 The society shall meet once a week for a presentation by the research Fellows. The research could include a documentary, a speaker, a debate or a workshop.
  - 4.3.2 Social events with other societies and Universities in London.

4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:

These are the activities that you would like to carry out every academic year if you can. The Union will support these activities but not fund them.

4.4.1 The MPH society will also have an optional social after every meeting to meet and discuss in a more casual setting. The MPH shall provide some beverages in this optional after-meeting discussion.

4.5 This constitution shall be binding on the club/society officers. It shall only be altered by consent of a two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.

4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Modern Political History Society. By signing this document, the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
