

# 2024-25 Constitution of Students' Union UCL

# **Ahlul-Bayt Islamic Society**

#### 1. Name

- 1.1. The name of the club/society shall be Students' Union UCL Ahlul-Bayt Islamic Society.
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

#### 2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum & Articles of Association</u>, <u>Byelaws</u>, <u>Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

# 3.4.1. Secretary

3.4.1.1. To take responsibility for taking and distributing minutes after meetings within the society and with external bodies. To monitor the email inbox and liaise any important communications back to the President, Treasurer and committee members. To take ownership of all emails sent out to the mailing list.

# 3.4.2. Vice President

3.4.2.1. To assist the president in all aspects. Be prepared to take a leadership role in the absence of the President or otherwise

# 3.4.3. Interfaith Officer

3.4.3.1. Organise any events which involve or invite other faiths to attend. Ensure strong relations with other faith societies and promote unity in this respect

#### 3.4.4. Social Media Representatives

3.4.4.1. Keep all social media accounts of the society updated regularly. Set and aim to achieve monthly targets for growth on social media platforms. Design and publicise posters for events on social media. Be responsible for responding to messages on social media after liaising with the President and rest of committee if need be.

#### 3.4.5. Weekly Events Coordinator

- 3.4.5.1. Organise topics and layouts of weekly DKDCs (Dua Kumayl and Discussion Circles).

  Liaise with social media representatives to ensure maximum attendance
- 3.5. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

# 4. Terms, Aims and Objectives

4.1. The club/society shall hold the following as its aims and objectives.

  - 4.3.9. Roses for Peace campaign
- 4.4. The society shall also strive to organise other activities for its members where possible:
  - 4.4.1. Sports Tournaments
  - 4.4.2. Workshops
  - 4.4.3. Networking events
  - 4.4.4. Collaborations with other societies
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting.

  The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Ahlul-Bayt Islamic Society. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
