Constitution of Students' Union UCL

Business Society

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL Business Society.
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum &</u> <u>Articles of Association, Byelaws, Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. Committee

3.1. President

- 3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.
- 3.1.2. The President is accountable to the board for the overall performance of the society.

3.2. Treasurer

- 3.2.1. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
- 3.2.2. The Treasurer is also the Executive Director and is responsible for the organisation of internal scheduling and the disciplinarian of the society.

3.3. Welfare Officer

- 3.3.1. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.
- 3.3.2. Welfare Officer is responsible of overseeing the welfare and well-being of all members within the society
- 3.4. Additional Committee Members
 - 3.4.1. Vice President of Client Relations
 - 3.4.1.1. The Vice President of Client Relation's primary role is to ensure the organisation and execution of all sponsor-related events.
 - 3.4.2. Vice President of Competitions
 - 3.4.2.1. The Vice President of Competition's primary role is to organise the annual case study competition, DECA, as well as assist in arranging teams for the University Business Challenge (UBC).
 - 3.4.3. Vice President of Consulting
 - 3.4.3.1. The Vice President of Consulting's primary role is to ensure the execution of case clubs as well as all other consulting related activities.
 - 3.4.4. Vice President of Events
 - 3.4.4.1. The Vice President of Events' primary role is to ensure the organisation and execution of all events apart from sponsor related events.
 - 3.4.5. Vice President of Public Relations and Marketing
 - 3.4.5.1. The Vice President of Public Relation's primary role is to design all online and offline marketing materials for the Society.
 - 3.4.6. Vice President of Social Enterprise
 - 3.4.6.1. The Vice President of Social Enterprises' primary role is to organise all activities pertaining to Corporate Social Responsibility and social enterprises for the Society.
 - 3.4.6.2. The Vice President of Social Enterprises' also holds the role of the community outreach officer.

- 3.5. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:
 - 4.3.1. Sponsors' events, including recruitment talks and training workshops
 - 4.3.2. Career information sessions
 - 4.3.3. Organise the annual DECA competition
- 4.4. In addition, the club/society shall also strive to organise other activities for its members where possible:
 - 4.4.1. Social activities for networking with like-minded individuals
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Business Society. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
