Constitution of Students' Union UCL

Football Red Star

- 1. Name
 - 1.1. The name of the club/society shall be Students' Union UCL Football Red Star.
 - 1.2. The Club/Society shall be affiliated to UCLU.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum &</u> <u>Articles of Association, Byelaws, Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. Committee

- 3.1. President
 - 3.1.1. The President's primary role is laid out in section 5.7 of the Club and Society Regulations.
 - 3.1.2. Overseeing the integration of social and squad members
- 3.2. Vice President
 - 3.2.1. The Vice-President's primary role is to aid the President in their roles as laid out in section5.7 of the Club and Society Regulations

- 3.2.2. If the president should be unable to fulfil their role, the Vice President will assume their responsibilities
- 3.3. Treasurer
 - 3.3.1. The Treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
- 3.4. Welfare Officer
 - 3.4.1. The Welfare Officer's primary role is laid out in section 5.9 of the Club and Society Regulations.
- 3.5. Social Secretary x 3
 - 3.5.1. The Social Secretary's primary role is to organise and communicate details of social events organised by the society.
- 3.6. Kit Manager
 - 3.6.1. The Kit Manager's primary role is to organise Red Star FC's football kits across all teams. This includes LUSL, personal and tour kits. They are also responsible for developing and/or overseeing any and all Red Star FC merchandise.
- 3.7. 5-a-side Manager
 - 3.7.1. The 5-a-side manager's primary role is to organise all 5-a-side social games within the club.He must ensure a minimum of one 5-a-side game per week and that these are accessible to all Red Star FC members.
- 3.8. First Team Captain
 - 3.8.1. The First Team Captain's primary role is to organise the first team in terms of their fixtures, training, team selection and management.
- 3.9. First Team Vice-captain
 - 3.9.1. The First Team Vice-captain's primary role is to aid the First Team Captain in their roles as laid out in section 3.6.1
 - 3.9.2. If the First Team Captain should be unable to fulfil their role, the First Team Vice-captain will assume their responsibilities.
- 3.10. Second Team Captain

- 3.10.1. The Second Team Captain's primary role is to organise the second team in terms of their fixtures, training, team selection and management.
- 3.11. Second Team Vice-captain
 - 3.11.1. The Second Team Vice-captain's primary role is to aid the Second Team Captain in their roles as laid out in section 3.8.1
 - 3.11.2. If the Second Team Captain should be unable to fulfil their role, the Second Team Vicecaptain will assume their responsibilities.
- 3.12. Third Team Captain
 - 3.12.1. The Third Team Captain's primary role is to organise the third team in terms of their fixtures, training, team selection and management.
- 3.13. Fourth Team Captain
 - 3.13.1. The Fourth Team Captain's primary role is to organise the fourth team in terms of their fixtures, training, team selection and management.
- 3.14. Management of the society shall be vested in the Society Committee which shall endeavour to meet regularly during term time (excluding college reading weeks) to organise and evaluate the Society's activities.
- 3.15. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.16. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:
 - 4.3.1. To provide social but competitive football opportunities to students at UCL

- 4.3.1.1. These opportunities should not compete with the performance opportunities offered by the Men's Football Club, or the solely social/recreational opportunities offered by the Departmental Teams system, or Project Active
- 4.3.1.2. As such, core activities of the club, where possible, should not conflict with the aforementioned alternatives
- 4.3.1.2.1. Specifically, trial dates should not clash with UCL Men's Football Club
- 4.3.1.2.2. The non-competitive, informal 5-a-side sessions mentioned at 4.3.3 should be run in conjunction with Project Active sessions to ensure efforts are not duplicated.
 - 4.3.1.3. The main purpose of these opportunities should be to fill the gap between UCL's major performance football club, and the purely 'for fun' opportunities which exist elsewhere.
 - 4.3.1.4. The society shall offer football that is competitive, and regular, taking advantage of the Wednesday and/or Saturday LUSL leagues.
 - 4.3.1.5. The society shall offer social activities for all members, in keeping with its inclusive, social but competitive football ethos.
 - 4.3.2. To participate in regular competitive football fixtures
 - 4.3.3. To provide informal, non-competitive weekly 5-a-side or 7-a-side sessions open to players of all abilities.
 - 4.3.3.1. This shall be subject to the aforementioned caveat at 4.3.1.2.2
 - 4.3.4. To organise social activities for all club members.
 - 4.4. In addition, the society shall also strive to organise other activities for its members where possible. These may include, but are neither compelled to be nor limited to:
 - 4.4.1. Charity 5-a-side tournament
 - 4.4.2. Annual interclub fixtures
 - 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.

4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Football Red Star. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
