Constitution of Students' Union UCL

Indian Dance Society

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL **Indian Dance Society**.
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. The Society Committee

3.1. President

- 3.1.1 The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.

3.2. Treasurer

- 3.2.1 The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.

3.3. Welfare Officer

- 3.3.1 The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.

Additional Committee Members

3.4 Creative Officer

- 3.4.1 Working alongside social media and marketing officer for all social media platforms. Creative officer is expected to edit weekly dance class videos, alongside any music for events/workshops and the Just Bollywood national dance competition

3.5 Social Media and Marketing officer

- 3.5.1 To work closely with the creative officer to promote Indian Dance society on all social media platforms. This will include creating dance classes and updates of the Just Bollywood national dance competition.

3.6 Dance Class Directors x2

- 3.6.1 Expected to teach up to 50 seconds of choreography, alongside running extra workshops in collaboration with other societies and universities.

3.7 Just Bollywood Dance Directors x3

- 3.7.1 Expected to lead UCL Just Bollywood dance team and choreograph the mini round.

3.8 Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.



3.9 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.

3.10 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The **core activities** of the club/society shall be:
- 4.3.1 The society aims to teach weekly dance classes. We aspire to offer a diverse range of classes representing different styles of Indian Dance including Bollywood, Kathak and Bharatanatyam.
 - 4.3.2 In addition to weekly dance classes, we aim to lead workshops correlating with Indian festivals such as Diwali and Navratri.
 - 4.3.3 We aim to support and publicise the Indian Dance team forward for the Just Bollywood Dance Competition.
- 4.4 In addition, the club/society shall also strive to organise **other activities** for its members where possible:
- 4.4.1 Participating in the Just Bollywood National Competition.
 - 4.4.2 Leading annual workshops based on Indian festivals. These workshops will be hosted in partnership with related societies such as Indian/ Hindu Society.
- 4.5 This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.

This constitution has been approved and accepted as the Constitution for the Students' Union UCL **Indian Dance Society**. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
