## **Constitution of Students' Union UCL**

### Ahmadiyya Muslim Students' Society

#### **1. Name**

- 1.1. The name of the club/society shall be Students' Union UCL **Ahmadiyya Muslim Students' Society**
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

#### **2. Statement of Intent**

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association, Byelaws, Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

#### **3. Committee**

##### **3.1. President**

- 3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.

##### **Treasurer**

- 3.1.2. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.

##### **Welfare Officer**

- 3.1.3. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.

### Additional Committee Members

- 3.2. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.3. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.4. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The **core activities** of the club/society shall be:
  - 4.3.1. To provide an official space for Ahmadi Muslim students at UCL to network, socialise and hold events.
  - 4.3.2. To conduct interfaith work and networking with other faith societies so as to build the bonds of friendship in all that we have in common.
  - 4.3.3. To facilitate pastoral support for members alongside professional mentoring opportunities, especially to those from BAME and minority groups. This will primarily occur through the vehicle of AMSS's 'Apex Programme'
  - 4.3.4. To encourage a sense of healthy discussion and dialogue with other societies on matters that are relevant to both the AMSS and other societies
- 4.4. In addition, the club/society shall also strive to organise **other activities** for its members where possible:
  - 4.4.1. Social dinners
  - 4.4.2. Social sports tournaments
  - 4.4.3. Charity fundraising events
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.

- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL [Ahmadiyya Muslim Students' Society](#)
- 4.7. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
