

2024-25 Constitution of Students' Union UCL

Skate Club

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL Skate Club.
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum & Articles of Association</u>, <u>Byelaws</u>, <u>Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. Committee

3.1. President

3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.

3.2. Treasurer

3.2.1. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.

3.3. Welfare Officer

- 3.3.1. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.
- 3.3.2. The welfare officer's additional roles include:

- 3.3.2.1. Suggesting and organising activities related to Student's Union initiatives such as Project Active, This Girl Can, Men's Health Active, Postgraduate Events etc
- 3.3.2.2. Organising volunteering activities for the club and its members

3.4. Additional Committee Members

- 3.4.1. Vice President They manage the internal affairs of the society and would:
 - 3.4.1.1. Take meeting minutes
 - 3.4.1.2. Organise the timeline for events and activities
 - 3.4.1.3. Manage the society newsletter
- 3.4.2. Marketing Officer Their primary role is to promote the society's events and attract members and would:
 - 3.4.2.1. Manage the club's social media accounts and online presence
 - 3.4.2.2. Advertise upcoming events
 - 3.4.2.3. Respond to enquiries raised through society social media platforms
- 3.4.3. Social Secretary Their primary role is to improve morale in the society and engage its members such as by:
 - 3.4.3.1. Organising social skating events
 - 3.4.3.2. Organising social non-skating events
 - 3.4.3.3. Forming partnerships with other social skate groups
- 3.4.4. Equipment Officer They manage all equipment and kit of the club, and would:
 - 3.4.4.1. Work with the treasurer to source equipment
 - 3.4.4.2. Maintain equipment in good condition
 - 3.4.4.3. Be involved in designing the kit and merchandise
 - 3.4.4.4. Work with the marketing officer and treasurer to sell and/or distribute kit and merchandise
- 3.4.5. Inline Skating Captain Their primary role is to promote and educate in inline skating, and they would:
 - 3.4.5.1. Be experienced or passionate in Inline Skating and it's various disciplines
 - 3.4.5.2. Run regular skating sessions and engage with all members
 - 3.4.5.3. Be involved in organising events and partnerships relating to Inline Skating
- 3.4.6. Skateboarding Captain Their primary role is to promote and educate in skateboarding, and they would:
 - 3.4.6.1. Learn or have knowledge about Skateboarding and it's various disciplines

- 3.4.6.2. Run regular skating sessions and engage with all members
- 3.4.6.3. Be involved in organising events and partnerships relating to Skateboarding
- 3.4.7. Quad Skating Captain Their primary role is to promote and educate in Quad Skating, and they would:
 - 3.4.7.1. Learn or have knowledge about Quad Skating and it's various discipline
 - 3.4.7.2. Run regular skating sessions and engage with all members
 - 3.4.7.3. Be involved in organising events and partnerships relating to Quad Skating
- 3.4.8. Longboarding Captain Their primary role is to promote and educate in Longboarding, and they would:
 - 3.4.8.1. Learn or have knowledge about Longboarding and it's various disciplines
 - 3.4.8.2. Run regular skating sessions and engage with all members
 - 3.4.8.3. Be involved in organising events and partnerships relating to Longboarding
- 3.5. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:
 - 4.3.1. Student led skating classes for beginners
 - 4.3.2. Regular practice sessions, open to all skills levels, which allow focussing on specific disciplines of skating

- 4.3.3. Maintenance workshops which educate and provide materials to keep equipment in good condition
- 4.3.4. Social events for the members to get to know one another
- 4.3.5. Joining other skating clubs and/or public skating events
- 4.4. In addition, the club/society shall also strive to organise **other activities** for its members where possible:
 - 4.4.1. Presentations on the different types and disciplines of skating to orient beginner and promote the various niches of skating
 - 4.4.2. Coaching for specific disciplines of skating if there is sufficient interest
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting.

 The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Skate Club. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
