# **Constitution of Students' Union UCL**

# **Student Inclusion Health Society**

- 1. Name
  - 1.1. The name of the club/society shall be Students' Union UCL Student Inclusion Health Society.
  - 1.2. The Club/Society shall be affiliated to Students' Union UCL.

#### 2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum &</u> <u>Articles of Association, Byelaws, Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

- 3.4. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.5. The committee members shall perform the roles as described in section 5 of the Students'Union UCL Club and Society Regulations.
- 3.6. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

### 4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
  - 4.1.1. To empower students to engage in inclusion health initiatives through capacity-building workshops and community-based partnerships.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:

- 4.3.1. Facilitate workshops to develop students' understanding of their role as healthcare leaders within the community and in combating health disparity.
- 4.3.2. Establish sustainable partnerships with organisations working with disadvantaged groups in the local community to improve health outcomes for service users.
- 4.3.3. Run events educating the student community on Inclusion Health and its relationship with health outcomes
- 4.3.4. Create social and networking opportunities for students to interact with each other and those advancing health equity
- 4.4. In addition, the club/society shall also strive to organise other activities for its members where possible:

4.4.1. Support students to identify passion projects and build own initiatives

- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL Student Inclusion Health Society. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
