Constitution of Students' Union UCL

Men's Football Club

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL [Men's Football Club](#).
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

- 3.1. President: Eduardo Holovatyuk
 - 3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.
- 3.2. Treasurer: Gustavo Alves de Albuquerque
 - 3.2.1. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
- 3.3. Welfare Officer: Josh Howes
 - 3.3.1. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.
- 3.4. Additional Committee Members

- 3.4.1. Social Secretaries: Tom Dolan and Kaiyan Wilson
 - 3.4.1.1. Organise club social events, notably Wednesday night socials.
- 3.4.2. Charity Secretary: Rory Stewart
 - 3.4.2.1. Responsible for enhancing the club's charitable output and ensuring the club's fundraising efforts (notably Movember) are successful.
- 3.4.3. Tour Secretaries: Kai Jarvest Chen and Ollie Brennan
 - 3.4.3.1. Oversee and manage the booking of both the club's annual national and international tours.
- 3.4.4. Fixture, Referee and Varsity Secretary: Konstantin Mamkhegov
 - 3.4.4.1. In charge of booking referees and sometimes pitches for fixtures. Responsible for communicating to captains what referees will be taking charge of each game. They are a critical figure in organising our annual varsity match against King's College London towards the end of the year. Should also work in conjunction with the Club President and Social Secretaries to plan and organise the event so that club members get the most enjoyment out of the day, whilst most importantly being safe.
- 3.4.5. Diversity Secretary: Ibrahim Zaazou
 - 3.4.5.1. Ensure the club is inclusive of all people who are eligible to join, and work to encourage people from diverse backgrounds to become members.
- 3.4.6. Social Media Secretary: Jacob Cockram
 - 3.4.6.1. Designated lead in managing all our active social media outlets, predominantly Instagram, Facebook, and Twitter. Content will include the promotion of initiatives & fundraising campaigns, important club updates, as well as fun content to boost engagement.
- 3.5. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by

the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:
 - 4.3.1. Weekly training sessions for all teams
 - 4.3.2. Matches in BUCS, LUSL and perhaps TeamUCL Leagues
 - 4.3.3. Wednesday Sports Night Socials
 - 4.3.4. Varsity
 - 4.3.5. Formal and informal AGM
- 4.4. In addition, the club/society shall also strive to organise other activities for its members where possible:
 - 4.4.1. Movember fundraising activities
 - 4.4.2. Food Nights and other socials
 - 4.4.3. Individual Club Team socials
 - 4.4.4. Tour: both domestic and international
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL [Men's Football Club](#). By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
