Constitution of Students' Union UCL

Fashion Business Society

1. Name

- 1.1. The name of the club/society shall be Students' Union UCL [Fashion Business Society](#).
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3. Committee



- 3.1. President
 - 3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.
 - 3.1.2. The president will act on behalf of the society to provide support members and committee to improve their understanding of what 3d modelling is about and to create a healthy and fun environment in which everyone can express themselves and create.
 - 3.1.3. The president must fill or find persons to fill the roles of committee members who are absent or lacking.

- 3.1.4. The president will have to mediate between committee members and make sure that all members are fulfilling their roles accordingly.
- 3.2. Treasurer
 - 3.2.1. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
 - 3.2.2. The treasurer will manage the budget and work with other committee members to find sponsors.
 - 3.2.3. The treasurer will be in charge of deals with software providers and obtain necessary licenses when needed.
- 3.3. Welfare Officer
 - 3.3.1. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.
- 3.4. Additional Committee Members
 - 3.4.1. [Social Media Director](#)
 - 3.4.2. The appointed person will be in charge of handling the society's social media handles and creating relevant content for the same
 - 3.4.3. [External and Internal Relations Director](#)
 - 3.4.4. The appointed person will be required to reach out to other UCL societies and external organisations for collaborating on events
 - 3.4.5. [Marketing Strategy Director](#)
 - 3.4.5.1. The appointed person will be responsible for creating marketing content and promoting the events and the society
 - 3.4.6. [Strategy Director](#)
 - 3.4.6.1. The appointed person will be responsible for planning the future timeline for the club, ways to enhance its position and expand it etc.
- 3.5. club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by

the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The core activities of the club/society shall be:
 - 4.3.1. Social Events
 - 4.3.2. Workshops and Seminars
 - 4.3.3. Lectures
- 4.4. In addition, the club/society shall also strive to organise other activities for its members where possible:
 - 4.4.1. Trips
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students' Union UCL [Fashion Business Society](#). By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
