

## The Constitution of Students' Union UCL

### CLIMBING AND MOUNTAINEERING CLUB

#### 1 Name

- 1.1 The name of the club/society shall be Students' Union UCL CLIMBING AND MOUNTAINEERING CLUB.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

#### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

#### 3 The Society Committee

##### President

- 3.1 The president's primary role is laid out in section 5.7 of the Club and Society Regulations.

- 3.3 The welfare officer's primary role is laid out in section 5.9 of the Club and Society Regulations.

- 3.5 Roles of the various committee positions are laid out in supplementary documentation
- 3.6 Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.7 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.8 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:
  - Organise Welcome talk and introduction for new members
  - Organise Taster Sessions at the Castle Climbing Centre
  - Compete in the London University Bouldering Event (LUBE) organised by KCL
  - Participate in BUCS Competitions
  - Renew membership with the British Mountaineering Council (BMC) and sign up all willing club members to also be BMC members
  - Send at least two committee members to the BMC Safety Seminar
  - Organise an introductory climbing trip and an entry-level mountaineering/scrambling trip.
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:
  - Organise social events
  - Organise additional trips to outdoor areas for mountaineering climbing activities
  - Organise speakers from organisations from the BMC or alpine Club
  - Help new climbers and mountaineers progress by providing advice and help whenever possible.
- 4.5 This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Zone shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Climbing and Mountaineering Club. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
