

# The Constitution of Students' Union UCL

## UCL Golf Club

### 1 Name

- 1.1 The name of the club/society shall be Students' Union UCL UCL Golf Club.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

### 3 The Society Committee

#### President

- 3.1 The president's primary role is laid out in section 5.7 of the Club and Society Regulations.  
The president in our society is just a member of the committee who takes more responsibilities with the union.  
Each member of the committee can occasionally cover tasks of other member of the committee if necessary.

#### Treasurer

- 3.2 The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.  
The treasurer will assist the president and vice president in planning, focusing on the budget for events. The treasurer will also attempt to source grants or additional funding to add to the club's budget.

#### Welfare Officer

- 3.3 The welfare officer's primary role is laid out in section 5.9 of the Club and Society Regulations.  
The welfare officer will organise weekly training sessions, ensuring that all members know where training is held and how to get there. The welfare officer will ensure the welfare of club members and act as a point of contact for all members of the club.

#### Additional Committee Members

- 3.4 Vice President  
The vice president will act as the president when the president is absent. The vice president will also manage the Facebook page, Instagram account and social outreach of the club, and also manage email correspondence with members of the club to update them of training sessions and other activities.

- 3.5 **Outreach Officer**  
The outreach officer will manage the club's relations with external golf clubs and other organisations to advance the interests of UCL golf. This includes booking potential training spaces in accordance with different training events, including driving range, short game practice or rounds of golf.
- 3.6 **Captain**  
The captain will organise playing of golf on the golf course among members, ensuring that the opportunity to play the sport is spread fairly and evenly among members. The captain will be responsible for ensuring that people playing on the course meet minimum requirements of skill, etiquette and safety awareness to do so. The captain will also organise highly skilled golfers who wish to participate in competitive university golf.
- 3.7 Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.8 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.9 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:  
Weekly training session, including access to the driving range, chipping area, putting green. Practice fundamentals. We will also include trips to the golf course for casual rounds. This is the sport in its true form. Rounds can be submitted for members to track their progress. Lastly, we will have games against other universities, both casual and competitive.
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:  
Watch competitive golf tournaments and mini-golf and top golf outings. These casual forms of the sport serve as both socials and fun introductions.
- 4.5 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Zone shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL UCL Golf Club. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
