

# The Constitution of Students' Union UCL

## Era Journal

### 1 Name

- 1.1 The name of the club/society shall be Students' Union UCL Era Journal.
- 1.2 The Era Journal shall be affiliated to Students' Union UCL.

### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the Era Journal shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The Era Journal stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that Era Journal regulations pertaining to membership of the Era Journal or election to the Era Journal shall not contravene this policy.

### 3 The Society Committee

#### President

- 3.1 The president's primary role is laid out in section 5.7 of the Club and Society Regulations.
- 3.2 It is the responsibility of the President to maintain the core values of Era Journal, which are as follows:
  - 3.2.1 To provide a quasi-academic online and print publication, which fuses cultural integrity and artistic endeavours.
  - 3.2.2 To promote and nurture student talent at UCL.
  - 3.2.3 To ensure Era Journal's content and membership are representative of and accessible to all of UCL's student community.

#### Treasurer

- 3.3 The Treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
- 3.4 The Treasurer will also act as Events Manager, and seek to establish Era Journal's longevity and sustainability through both of these inextricably linked roles.

#### Welfare Officer


- 3.5 The welfare officer's primary role is laid out in section 5.9 of the Club and Society Regulations.


## Additional Committee Members

- 3.6 Editor-in-Chief and Senior Editor will also be voted into their respective positions at the Society's AGM. Additional committee members will be appointed after the AGM by the incoming and outgoing committees.
- 3.7 All committee members, including additional committee members, will maintain Era Journal's core values, as outlined in 3.2.
- 3.8 Management of the society shall be vested in the society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate society activities.
- 3.9 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.10 Committee members are elected to represent the interests and well-being of Era Journal members and are accountable to their members. If Era Journal members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4 Terms, Aims and Objectives

- 4.1 The Era Journal shall hold the following as its aims and objectives.
- 4.2 The Era Journal shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the Era Journal shall be:
  - 4.3.1 To maintain the integrity of the Society's online journal.
  - 4.3.2 To produce two print publications per academic year.
  - 4.3.3 To carry out both of the above in accordance with the core values outlined in 3.2.
- 4.4 In addition, the Era Journal shall also strive to organise other activities for its members where possible:
  - 4.4.1 Host events to publicise Era Journal's print editions and showcase university talent, artistic endeavours and original work, whilst raising money for the funding of Era Journal's print editions.
- 4.5 This constitution shall be binding on the Era Journal officers, and shall only be altered by consent of two-thirds majority of the full members present at a Era Journal general meeting. The Activities Executive shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Era Journal. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
