

# 2024-25 Constitution of Students' Union UCL

# **GEORGIAN SOCIETY**

## 1. Name

- 1.1. The name of the society shall be Students' Union UCL Georgian Society.
- 1.2. The Georgian Society shall be affiliated to Students' Union UCL.

### 2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the Georgian Society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL</u> <u>Memorandum & Articles of Association</u>, <u>Byelaws</u>, <u>Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The Georgian Society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that Georgian Society regulations pertaining to membership of the Georgian Society or election to the Georgian Society shall not contravene this policy.

## 3. Committee

#### 3.1. **President**

- 3.1.1. The Presidents' primary role is laid out in section 5.7 of the Club and Society Regulations.
- 3.1.2. The president shall act in the best interests of the UCL Georgian Society and ensure that Georgian culture is well-represented.

#### 3.2. **Treasurer**

3.2.1. The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.

#### 3.3. Welfare Officer

3.3.1. The Welfare Officers' primary role is laid out in section 5.9 of the Club and Society Regulations.

# 3.4. Vice-president

3.4.1. The vice president's primary role is to assist the president in the organization of events and society activities and running meetings in the absence of the president.

## 3.5. Social Secretary

3.5.1. The social secretary's primary role will be organising social events: reaching to relevant societies, organisations and institutions for cooperation. In case of the position's vacancy the responsibilities are transmitted to the President.

# 3.6. Communications Manager

- 3.6.1. The Communications Manager's primary responsibility will be managing the society's social media (WhatsApp Chat, Instagram, Facebook, LinkedIn) and newsletter. In case of the position's vacancy the responsibilities are transmitted to the President.
- 3.7. Management of the Georgian Society shall be vested in the Georgian Society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate Georgian Society activities.
- 3.8. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.9. Committee members are elected to represent the interests and well-being of Georgian Society members and are accountable to their members. If Georgian Society members are not satisfied by the performance of their representative officers, they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

# 4. Terms, Aims and Objectives

- 4.1. The Georgian Society shall hold the following as its aims and objectives.
- 4.2. The Georgian Society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The **core activities** of the Georgian Society shall be:
  - 4.3.1. Formal events (in person and/or online), including lectures, possibly with external speakers.
  - 4.3.2. Social events, including film screenings, food and alcohol tasting events and pub quizzes.
- 4.4. In addition, the Georgian Society shall also strive to organise **other activities** for its members where possible:
  - 4.4.1. Visits to relevant sites in London or elsewhere
  - 4.4.2. Georgian language workshops

# 4.4.3. Georgian Dance classes

- 4.5. This constitution shall be binding on the Georgian Society officers and shall only be altered by consent of two-thirds majority of the full members present at a Georgian Society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students'
  Union UCL **Georgian Society**. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
