

The Constitution of Students' Union UCL

UCL Kickboxing Club

1 Name

- 1.1 The name of the club/society shall be Students' Union UCL [UCL Kickboxing Club](#).
- 1.2 The club/society shall be affiliated to Students' Union UCL.

2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association, Byelaws, Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the 'how to guides'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

3 The Society Committee

President

- 3.1 The president's primary role is laid out in section 5.7 of the Club and Society Regulations.
 - (i) Be the principal officer of the named club/society and shall ensure that the club/society operates within its constitution and within the Club and Society Regulations.
 - (ii) Call general meetings of the named club/society and shall ensure the appropriate elections, for the following year's officers take place.
 - (iii) Be the primary point of contact between the Union and the named club/society members. They must ensure that the club/society is represented at all relevant Union networks and committees.
 - (iv) Have ultimate responsibility for all of the activities of the named club/society, including ultimate responsibility for all financial affairs.

Treasurer

- 3.2 The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.
 - (i) Be responsible for all financial matters of the named club/society, and shall ensure they operate within the club/society constitution and within Club and Society Regulations.

- (ii) Authorise all expenditure on behalf of the named club/society except for when they need to reclaim the money themselves, in which case the president shall authorise this expenditure.
- (iii) Be responsible for completing the relevant grant application forms for the named club/society.
- (iv) Provide the president with regular reports on the financial affairs of the club/society.

Welfare Officer

3.3 The welfare officer's primary role is laid out in section 5.9 of the Club and Society Regulations.

- (i) Be the only Officer of the Club or Society with access to the Welfare Officer Funding Pot and is responsible for applications and initiatives using that funding.
- (ii) Be responsible for the activity specified within the Welfare Officer remit including collaboration with other Welfare Officer in creation of demographic specified activity, recording of demographic specified membership and aware of the wider Union campaigns relevant to their Club or Society, specified or otherwise, on the Welfare Officer Campaign Timeline.
- (iii) Attend the annual Welfare Officer Training day.

Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.

The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.

Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:
To provide Kickboxing sessions lead by a fully qualified external instructor, with each session comprising of three parts: stretching, stamina building and flexibility; fighting technique practice & consolidation; and finally, light sparring.
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:
To provide social sessions to engage the club communication and to provide informative sessions to extend the awareness of Kickboxing and related topics.
- 4.5 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL [UCL Kickboxing Club](#). By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
