

The Constitution of Students' Union UCL

UCL Shakespeare Company

1 Name

- 1.1 The name of the club/society shall be Students' Union UCL [UCL Shakespeare Company](#).
- 1.2 The club/society shall be affiliated to Students' Union UCL.

2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.

4 Terms, Aims and Objectives

- 4.1 The club/society shall hold the following as its aims and objectives.
- Celebrating and engaging with the work of Shakespeare
 - Encouraging discussion about Shakespeare, especially personal and modern perspectives that involve race, gender, sexuality etc
 - Creating diverse and unique reinterpretations of his plays
- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.

The core activities of the club/society shall be:

- Auditions, rehearsals, and performances for/of two full length Shakespeare plays
- Auditions, rehearsals, and performances for/of at least one Shakespeare scene festival
- Frequent Shakespearean discussion forums
- Fortnightly social events, such as playwatches, trips, and gatherings

In addition, the club/society shall also strive to organise other activities for its members where possible:

- Talks on Shakespeare and renaissance culture by UCL academics
- Collaborate with other UCL societies, particularly musical, cultural, and performance-based ones

- 4.3 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.4 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Shakespeare Company. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
