

# 2024-25 Constitution of Students' Union UCL

# **Sudanese Society**

#### 1. Name

- 1.1. The name of the club/society shall be Students' Union UCL **Sudanese Society**.
- 1.2. The Club/Society shall be affiliated to Students' Union UCL.

#### 2. Statement of Intent

- 2.1. The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the <u>Students' Union UCL Memorandum & Articles of Association</u>, <u>Byelaws</u>, <u>Club and Society Regulations</u> and the club and society procedures and guidance laid out in the 'how to guides'.
- 2.2. The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

# 3.4.1. Vice-president

- **3.4.2.** Assist the president with decision-making, planning the event calendar, executing tasks, and communicating with committee and society members.
- **3.4.3.** Step in for the president during their absence, carrying out the president's duties when they are unavailable.
- **3.4.4.** Help plan, organize, and execute events and activities for the society.
- **3.4.5.** Address any conflicts or issues within the society, promoting a positive environment.

#### 3.4.6. Events Officer

- 3.4.6.1. Design, plan, and organize events that align with the society's goals and interests.
- 3.4.6.2. Establish and manage timelines to ensure all event-related tasks are completed on schedule.
- 3.4.6.3. Gather feedback from attendees post-event to assess success and identify areas for improvement.
- 3.4.6.4. Maintain records of past events, including budgets, attendance, and evaluations, to inform future planning.
- 3.4.6.5. Oversee the execution of events, ensuring everything runs smoothly on the day.
- 3.5. Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.
- 3.6. The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.7. Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers, they may call for a motion of noconfidence in line with the Students' Union UCL Club and Society Regulations.

# 4. Terms, Aims and Objectives

- 4.1. The club/society shall hold the following as its aims and objectives.
- 4.2. The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3. The **core activities** of the club/society shall be:
  - 4.3.1. Charity initiatives

- 4.3.5. Eid event
- 4.3.6. Speaker events
- 4.4. In addition, the club/society shall also strive to organise **other activities** for its members where possible:
  - 4.4.1. Football tournaments
- 4.5. This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Executive shall approve any such alterations.
- 4.6. This constitution has been approved and accepted as the Constitution for the Students'
  Union UCL **Sudanese society**. By signing this document, the President and Treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
