Preliminary matters – Approval of minutes from previous meeting
 The minutes from the previous meeting could not be approved as the meeting was not quorate

- 3. Announcements/ Updates Officer updates
 The Officers provided updates on the work they have been doing since the last Zone meeting.
- 4. Announcements/ Updates Staff update

 The staff present provided an update on the work being done within their teams currently.
- 5. Announcements/ Updates Affiliations, disaffiliations and disciplinary actions
 The Chair updated members on recent affiliations, disaffiliations and disciplinary actions
 taken since the last Activities Zone meeting. There were no affiliations or disaffiliations.
- 6. Announcements/ Updates Club and Society Grant Allocation 2021/22
 The Chair updated members on Club and Society Grant Allocations during the 2021/22

- 7. Announcements/ Updates Awards Update
 The Chair updated members on the Awards and reminded members of when they are taking place
- 8. Matters for Discussion UCL Strategy
 Frankie Quinn provided an update on the UCL Strategy, please see the slides in the papers. A brief discussion was had, and ideas were shared on this jambaord.
- 9. Matters for Discussion UCL East Update John Braime gave an update on UCL East. It was established that if any students had queries about UCL East, they should refer to Osman Teklies, the Union Affairs Officer. James Maidment raised the issue of TeamUCL and bringing clubs and societies to UCL East in a cohesive way. Please see the slides in the papers.
- 10. Matters for Discussion Changing 'remote' membership to 'taster' membership for clubs and societies Rupinder Sandal (RS) presented this matter. There was general agreement to this and the change will go ahead.
- 11. Matters for Discussion Increasing the amount students are allowed to spend and claim back to £350RS presented this matter. There was general agreement to this and the change will go ahead.
- 12. Matters for Discussion Club & Society Rules and Regulations updates RS presented on the updates, with only minor changes being made to the Rules and Regulations. These can be found in the papers.

13. Matters for Discussion - Overview of training plan
RS presented the training plan update for Clubs and Societies. There was varied discussion on
the core and compulsory training. Paul Ho agreed that the training looked comprehensive
and suggest this also be offered to the Liberation Officers as part of their training. It was also
suggested that the Tackling Sexual Violence training be made compulsory. Isobelle Smith also
suggested that some of this training should be extended to Social Secretaries. RS to take
feedback from Activities Zone to Student Activities Department

- 14. Policy Proposal Add option for multi-year membership of departmental societies The proposer (TS) introduced the policy about adding a multi-year membership option for departmental societies, proposing that this was a more straightforward option for members and those administering the membership. It was countered that often students sign up to membership of societies at the start of the year and then change their mind and want a refund. It was also noted that buying a multi-year membership could be made possible via the website, but would take some work. This policy could not be voted on as the meeting was not quorate.
- 15. Policy Proposal Open the role of postgraduate officer to all clubs and societies in term one The Postgraduate Officer (VM) introduced this policy, explaining that this is not a compulsory policy. James Maidment suggested that if the policy were to pass, additional support should be provided to Clubs and Societies on how the committee position would work. A discussion was had and there was general support for the policy, but it could not be voted on as the meeting was not quorate.
- 16. Policy Proposal Changes to leadership selection rules of society subdivisons The proposer (DS) introduced the policy about changing the leadership selection rules for society subdivisions. A discussion was had on the policy and concerns were raised about the responsibilities of the positions – especially if they were to hold political or financial powers. Democratic procedure and transparency were also discussed. This policy could not be voted on as the meeting was not quorate.
